**witnesses allowed to testify remotely, and** any division of such time among proponents, opponents, and those who wish to testify for information purposes [~~]; and a list of those approved to testify~~]. Only individuals who [~~receive approval to testify remotely from the committee and who~~] submit a completed, signed witness form shall be allowed to do so."; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.
